After you turn in your form for approval you will be given a numbered booth sign, which should be affixed to the front of your booth space on a tent pole or the front edge of a table. **In order to prevent multiple booths from offering the same Food/Beverage items Food/Beverage Categories will be limited to the non-profit group that signs up for them first.** Other categories are unlimited. You may only offer what you have been approved to offer at your booth. All vehicles must be unloaded and re-parked away from the circle on the Square by 5:30pm. The Parade will start at 6pm. You may operate your booth between 5 and 8pm and you are responsible for all trash pick-up/clean-up.
